Enacted: Continuing Appropriations Act, 2016 (P.L. 114-53); Consolidated Appropriations Act, 2016 (P.L. 114-113);
Zika Response and Preparedness Act, 2016 and Rescissions of Funds (P.L. 114-223, Divisions B and D)^e;
Continuing Appropriations Act, 2017 (P.L. 114-223, Division C)^e

- a. In fiscal year 2016, these amounts are subject to the caps on discretionary budget authority that were established by the Budget Control Act of 2011 (P.L. 112-25). The Bipartisan Budget Act of 2015 (P.L. 114-74) modified those caps to total \$1,066,582 million—\$548,091 million for defense programs and \$518,491 million for the nondefense programs.
- b. Designated pursuant to section 251(b)(2) of the Deficit Control Act; the spending limits for 2016 referenced in footnote a will be adjusted to accommodate these amounts.
- c. Section 745 of the Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2016, repurposes \$2 million that previously had been designated as an emergency requirement pursuant to an authority other than section 251(b)(2)(A)(i) of the Deficit Control Act of 1985; such spending does not allow for an adjustment to the discretionary caps.
- d. Certain provisions included in Divisions B-D of P.L. 114-223 provided supplemental appropriations for fiscal year 2016 which, on net, provided an additional \$1,208 million in budget authority in fiscal year 2016. CBO estimated that:
 - Division B would result in an additional \$1,108 million in budget authority in fiscal year 2016 for emergency requirements;
 - Section 145 of Division C would result in an additional \$500 million in budget authority in fiscal year 2016 for disaster relief; and
 - Division D would result in decreases in budget authority in fiscal year 2016 of \$232 million for emergency requirements, and of \$168 million for amounts not designated pursuant to section 251(b)(2) of the Deficit Control Act.

e. Sections 573-575 of the Department of Homeland Security Appropriations Act, 2016, (Division F of P.L. 114-113) provided for a one-year extension of several visa programs. In addition to the effects included here, CBO estimated that continuing those authorities would result in an increase in revenues in 2016 of \$1 million, and a decrease in revenues over the 2016-2025 period of \$4 million.
