Note: This estimate assumes enactment in mid-to-late September. Estimated outlays reflect a judgment as to when the Congress would enact this supplemental appropriation. It does not reflect any judgment about the amount of funds needed for these activities or when they are needed. Some of the funds may be obligated in fiscal year 2014, but not expended until fiscal year 2015 or later.

1. Division B of H.R. 5230, the Secure the Southwest Border Act of 2014, as passed by the House of Representatives on August 1, 2014, would amend the rules that apply to unaccompanied alien children. Among such changes, the bill would require the Department of Homeland Security to return all such children to their home country except in certain circumstances where the child is at risk of trafficking or persecution. The bill would also require the government to detain unaccompanied alien children who are not returned immediately, but who are instead awaiting removal proceedings. CBO considers it likely that enacting Division B would reduce the number of children present in the United States receiving means-tested federal benefits, thereby reducing direct spending for such benefits. However, CBO cannot estimate the potential reduction in direct spending at this time.
