Table 1 displays CBO's estimate of the fiscal year 2019-2028 budgetary effects of Rules Committee Print 116-2 for H.R. 268, the Supplemental Appropriations Act, 2019, as posted on the website of the House Committee on Rules on January 8, 2019. H.R. 268 would provide supplemental appropriations for fiscal year 2019 to respond to various natural disasters, and

designates those amounts as being for either emergency requirements or disaster relief pursuant to section 251 of the Balanced Budget and Emergency Deficit Control Act of 1985. The limits established by the Budget Control Act of 2011 (P.L. 112-25), as amended, would be adjusted to accommodate those amounts.
