



## CBO's Work in Progress as of July 6, 2020

To provide the Congress with a comprehensive review of its work, the Congressional Budget Office releases an annual report summarizing completed projects. The agency also publishes quarterly reports, like this one, highlighting recent activity and summarizing work in progress.<sup>1</sup>

### Recent Work

During the second quarter of 2020, CBO provided a variety of budget and economic analyses, fulfilling the agency's core mission of supporting the Congress during each stage of the legislative process. In addition to providing its regular analysis, CBO produced public and timely responses to Congressional inquiries and developed new approaches for assisting the Congress as it confronted the consequences of the 2020 coronavirus pandemic.<sup>2</sup> Those approaches included releasing budget and economic analysis more frequently and making certain budget analysis more accessible.

For example, CBO released a number of publications to provide current information about the rapidly changing economic outlook. In April, the agency published [preliminary information](#) about key economic variables in the near term; in May, it published *Interim Economic Projections for 2020 and 2021*; and last week, it published *An Update to the Economic Outlook: 2020 to 2030*. (CBO typically releases its economic projections along with its budget projections later in the summer, but this year, the economic projections were released early to provide the Congress with CBO's most current assessment of the economic outlook.)

Similarly, in response to Congressional requests, CBO published information about [federal funding for state and local governments](#) and about certain [budgetary effects of the coronavirus pandemic](#), including how tax deferrals will affect federal revenues and what laws enacted in response to the pandemic will have the largest effect on the federal budget deficit. CBO also provided a [comparison of its May 2020 interim projections of gross domestic product with its January 2020 baseline](#)

projections and responded to questions about the decline in those projections. Furthermore, CBO released an examination of the economic effects of additional unemployment benefits and provided information about the characteristics of people receiving regular unemployment benefits.

CBO continued to provide technical assistance and cost estimates as the Congress developed and considered legislation. Also, as a complement to the individual cost estimates provided for pandemic-related legislation, CBO released a matrix summarizing the budgetary effects of each pandemic-related law enacted in March and April. And CBO kept the Congress abreast of its plans, releasing a schedule for its major recurring reports and communicating schedule changes through its blog.

## Work in Progress

As of July 6, CBO was working on 96 cost estimates for legislation that had been ordered reported by a committee or that was the subject of a motion to be placed on the consensus calendar (see Table 1 on page 5). (CBO published 192 cost estimates in the first quarter of 2020 and 89 cost estimates in the second quarter.)

In addition, the agency was working on 29 analytic products that it expected to complete in the coming months.<sup>3</sup> (CBO published 25 such products in the first quarter of 2020 and 13 in the second quarter.)

Of the 29 ongoing products, two forthcoming reports are statutorily required:

- *Costs of Implementing the Recommendations of the 2019 Ballistic Missile Review* and
- *Sequestration Update Report*.

Four other reports that were under way as of July 6 are editions of reports that CBO produces on a regular basis to provide budgetary or economic information:

- *An Update to the Budget Outlook: 2020 to 2030*;
- *Monthly Budget Review for June 2020*;
- *Long-Term Implications of the 2021 Future Years Defense Program*; and
- *The Distribution of Household Income, 2017*.

Among the others that were under way, some will provide information about CBO's economic analyses:

- An evaluation of how tax changes affect the labor market differently during periods of high and low unemployment;

- An examination of the effects that federal policies adopted in response to the pandemic and recession are expected to have on economic outcomes;
- A technical description of a model CBO uses to inform its macroeconomic projections of the unemployment rate and the implications for business cycles;
- A technical description of the methods CBO uses to project the effects of policies on pharmaceutical innovation;
- A description of the methods CBO uses to estimate the size and work experience of the foreign-born population in the United States;
- An analysis of the extent to which changes in payroll taxes are passed through to employees' wages; and
- A description of how CBO models effective tax rates on capital income.

Others will explain or support the analytical methods used for CBO's budgetary estimates or provide background information:

- An evaluation of the accuracy of CBO's revenue projections;
- A report describing how the prices of brand-name prescription drugs are determined in different federal programs and comparing those prices among programs;
- An explanation of how CBO analyzes uncertainty surrounding baseline projections in *The Long-Term Budget Outlook*;
- A description of the methods CBO uses to estimate the cost of certain legislative proposals that require analysts to model the probabilities and costs of a range of potential outcomes;
- A short explanation of how statutory pay-as-you-go procedures operate;
- A reexamination of CBO's original estimate of the cost of the legislation establishing the Department of Defense Medicare-Eligible Retiree Health Care Fund; and
- An explanation of key scorekeeping guidelines and how CBO has used them to provide cost estimates for recent legislation.

Nine requested reports were in progress as of July 6:

- A report analyzing the costs of allowing the New START treaty to expire;
- An examination of the effects of federal student loan policies on borrowing, loan repayment, cancellation, discharge, and forgiveness;
- An analysis of the distribution of certain tax expenditures;

- An examination of the Internal Revenue Service's enforcement activities and their relationship to that agency's resources;
- A report analyzing the cost of the Navy's Future Frigate Program;
- A description of the guaranteed home loan program run by the Department of Veterans Affairs, including how it works, how it benefits veterans, and how it affects the federal budget;
- A report examining policies to approach universal health insurance coverage;
- A description of the population without health insurance; and
- An analysis of the effects of work requirements and programs that support work in means-tested transfer programs.

CBO makes known occasions when, in its work on requested analytic reports, the requester has made his or her request public or has permitted CBO to make the work public. Making those occasions known sometimes helps the agency gain outside feedback more effectively. Plans to publish other analytic reports are currently confidential. However, when the publication of an analytic report is imminent, CBO announces it, regardless of whether or not the plans were public or confidential up to that point.<sup>4</sup> Upon completion, all reports are available to the public on CBO's website.

The Congressional Budget Office prepares this report each quarter to help keep the Congress informed about the agency's work. Megan Lynch coordinated this edition, with contributions from many people at CBO. Jeffrey Kling reviewed the report, and Benjamin Plotinsky was the editor.
