Introduction to CBO


- CBO was created by the Congressional Budget and Impoundment Control Act of 1974.
- CBO's Director is appointed jointly by the House and Senate.
- The agency provides nonpartisan and objective analysis of budgetary and economic issues.

- An Evaluation of CBO's Past Revenue Projections (August 2020)


Deficits in CBO's September 2020 Baseline Versus Its March 2020 Baseline

Percentage of Gross Domestic Product



Percentage of Gross Domestic Product








The Output Gap

Percentage of Potential GDP




Changes in CBO's Economic Forecast Since January 2020






Deficit Increases Over the 2020–2030 Period From Legislation Enacted to Address the Coronavirus Pandemic, by Major Provision


